F. BACKGROUND AND EXPERIENCE

i. Please briefly present the partner organisation (e.g. its type, size, scope of work, areas of specific expertise and specific social context)

Our company operates under the name "Kıymet Selvi Education Support and Consultancy Limited Company" in Ankara University Technopolis region. As an R&D company, we carry out training activities at local, national, and international levels. Our main field of activity is to carry out innovative research and projects in the field of education. While carrying out these studies, our focus is on school education, adult education, and vocational education in the context of formal and nonformal education. These trainings are carried out face to face and via e-learning.

Within the scope of Educational Consultancy and Support activities, we design, research, develop, design, implement and evaluate curricula for all levels of education, from primary education to higher education, including VET education. In addition, studies are carried out on research method design, measurement and evaluation, test development, design of question banks, educational material design, training module design, and book or report writing. Some of the activities we carry out are briefly summarized below.

These studies are carried out at individuals and institutions levels. In addition to the abovementioned activities, seminars, trainings, project execution, and meetings are organized to strengthen individuals, institutions, and society on a voluntary basis.

ii. What are the activities and experience of the organisation

KSEDD company was established on June 2, 2022, and has participated in one international IP Project and has executed three national projects to date. Although the company was established a short time ago, it has experience in national and international projects and has provided training on many subjects. The activities carried out by the company are described below.

International Project Experience

iii. What are the skills and expertise of key staff/persons involved in this application?

KSEDD company has got a lot of persons who are experienced in different kind of education departments. The company carries out projects by making employment contracts with the best experts on a project-by-project basis.

One of them is our legal representative, Kıymet Selvi, who has experience in Erasmus and Horizon projects.

Selvi worked on a total of 17 projects. She served as coordinator in nine of these projects and as researcher in eight of them. She has ten years of experience as a systems analyst and computer programmer, and 25 years of experience as a university academic in the field of education. She made more than 50 visits abroad for education and scientific research.

Within the scope of the EU, she worked with countries such as Finland, Germany, Spain, England, Belgium and the Czech Republic, as the coordinator of the Anadolu University Erasmus Project in Faculty of Education between 2014 and 2017. In addition, she continues her work as a top-grade researcher in a Horizon project in which Ankara University participated as a partner with other eleven countries. The project started in November 2023.
